

Stephen Petrik, Anthony B. Carr Scholarship

Rules and Polices

Purpose

The purpose of the Stephen Petrik, Anthony B. Carr Scholarship Program to recognize personal achievement, to encourage the development of qualified scholars who have already proven themselves, and to assist these persons in obtaining a higher level of education.

Eligibility

To be eligible for consideration, an applicant must fulfill the following requirements:

- The applicant must be a relative of a member in good standing of the F.O.P., Regulars or Associates, Lodge #102.
- The sponsoring member cannot be on the Education Committee.
- The applicant must be a high school graduate and accepted to a trade school or college to receive the scholarship payment.
- The application form must be 1) answered completely; 2) submitted with the most recent high school, trade school or college transcripts; 3) at least two letters of recommendation from a suitable school official who is in a position to judge the applicant's accomplishments and promise.
- All documents must be received by the deadline June 30.

Selection

Selection of Scholarship awards will be based on the following criteria and guided by the following:

- Scholarships will be based on proven and substantiated academic and extracurricular achievements and future promise.
- Selection of scholarship awards will be determined by a delegation consisting of three members from the Associate Lodge's Education Committee and three members from the Regular Lodge's Education Committee.
- If comparable applicants exist, the Education Committee will attempt to award scholarships equally to applicants nominated by both the Regular and Associate members.
- If the quality of applicants does not meet the level of performance expected by the Education Committee, the committee reserves the right to renounce the awarding of one or more of the scholarships for that year. Undeclared Scholarships for that year will not be carried forward to subsequent years.
- Applicants who have not previously been awarded a scholarship will be given preference over applicants who have already been awarded a scholarship.

Awards

- No more than two scholarships will be awarded each year.
- Each scholarship will be made in the form of a \$500 check made payable to the recipient.
- Scholarship Certificates will be presented to the recipients in person at the August Corn Roast. Recipients are encouraged to have their immediate family present at the presentation.

Important Dates

- January - Scholarship forms are sent out with the dues notice.
- June 30 - Scholarship forms are due.
- August 1 - Scholarship recipients will be notified.
- August Corn Roast - Scholarships will be announced and certificates presented.
- Checks will be rendered once proof of enrollment in a trade school or college is demonstrated.

Funding

- Funding for the scholarships will be made available through public contributions and at least one joint Regular/Associate fund raising event.
